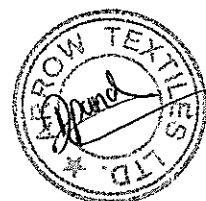

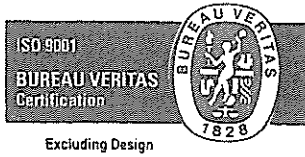
A. Date, time and venue of the Meeting:

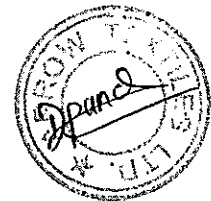
- The following items of business as set out in the Notice convening the AGM were put for shareholder's approval :

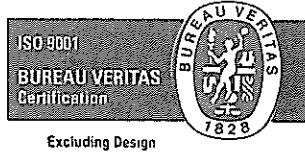
C. Ordinary Business:

1. Consideration and adoption of Audited Financial Statements for the year ended 31st March, 2017 together with the Reports of the Board of Directors and the Auditors thereon.
2. Declaration of dividend @ 15% on Equity Share Capital (i.e. ₹ 1.5/- per Equity Share of ₹ 10/- each) for the Financial Year ended 31st March, 2017.
3. Re-appointment of Mr. Chand Arora (DIN: 02784924) as a Director, retiring by rotation.
4. Appointment of M/s. M. H. S. & Associates, Chartered Accountants as Statutory Auditors of the Company in place of M/s. Amit Desai & Co., Chartered Accountants, whose term is expiring at the ensuing Annual General Meeting.
